**AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION**


The undersigned affiant, who, after being duly sworn by me, on oath makes the following:

I have good reason to believe and do believe that **JAMES EDWIN HOOD JR, DOB: 11/27/1970, 5 ft. 09 in., WEIGHT 185 lbs., RACE WHITE, M X F** hereinafter called the accused, whose Texas Driver's License/ID Number is **00442780** and who is last known to reside at **12007 Park Road 57, Somerville, TX 77879** did commit the offense of **Theft >=\$100<\$750**. My belief is based on the following facts:

On or about the 16<sup>th</sup> day of January 2021, in the County of Washington, and State of Texas, **JAMES EDWIN HOOD JR, DOB: 11/27/1970**, did then and there, unlawfully appropriate, by acquiring and otherwise exercising control over, property, namely conducting fraudulent returns for cash, of the value of \$100, or more, but less than \$750, from the Tractor Supply, 2817 S. Market ST, Brenham, Texas 77833, the owner thereof, with intent to deprive the owner of the property.

And it is further presented that the offense was committed in an area that was, at the time of the offense, subject to a declaration of a state of disaster made by the governor under Section 418.014 of the Texas Government Code.


WHEREFORE, the affiant requests the issuance of a warrant of arrest and detention for the accused in accordance with the law.
